

CE Marking - Construction Products Regulation (CPR)

Meet the requirements applicable to construction products to access the European Union market.



To access the European market, construction products must meet the quality and safety requirements defined in Construction Products Regulation 305/2011: Mechanical resistance and stability; fire safety; health, hygiene, and the environment; safety in use; protection against noise; and energy saving and thermal insulation.

The regulation establishes 5 categories of conformity evaluation systems, ranging from the manufacturer's statement at the lowest level to the involvement of a notified body in various stages for the other systems.

The manufacturer or its representative in the European Union is responsible for the declaration of performance and placement of the CE marking. It is therefore essential they identify which evaluation system is applicable to their product.
